In many parts of the world, safe injection practices as well as proper disposal of sharps remain a challenge. Infection prevention is integral to solving many of these problems. A number of initiatives have been put forth to address these issues. However, the success of these interventions is not well documented and in some locations problems still persist. In order to address this gap, IFIC is launching a Grant Proposal Competition aimed at infection prevention in low-resource settings. This initiative is made possible through the generous support of several companies: Stericycle, AP Medical, Smiths Medical, and WNWN International. The grant is for \$3,500 (USD).

### Dear Colleagues,

The run towards 5 May 2013 is reaching the last stages! Yet, we have still more ideas and tools to offer and support your efforts to respond to the WHO call to action for this year about hand hygiene monitoring and feedback and patient participation in hand hygiene promotion! By 5 May 2013, please help us achieve new registrations from at least 5 new countries that have NO facilities yet registered, especially in the African Region, and to increase registrations in countries with low numbers! See the list of countries with NO registrations or low numbers and encourage new facilities to register!

We have been informed that many national campaigns have picked up on our call and are getting ready to celebrate 5 May with a special focus on patient participation in hand hygiene promotion! Among WHO tools posted on the WHO web page dedicated to patient participation in hand hygiene promotion, we would like to highlight the document entitled "Guidance on Engaging Patients and Patient Organizations in Hand Hygiene Initiatives". This is very comprehensive guidance to understand patient empowerment, to facilitate ownership and shared responsibilities, and to develop your programme taking into account your local context.

This month we are also pleased to offer you a NEW TOOL called "Tips for implementing a successful patient participation programme". It has been developed thanks to the experienced advice and input of renown experts on this topic: Dr Maryanne McGuckin (McGuckin Methods International, USA) and Dr Yves Longtin (University of Quebec, Canada). We hope that it represents an easy checklist for you to identify and implement essential elements in your patient participation programme! This document also highlights a list of papers providing good examples of patient participation programmes, looking at implementation as well as an overview of barriers, solutions and strategies for both HCWs and patient participation/empowerment. Remember that you can access an inventory of videos of patient stories on our web site. If you know of any good videos of patient stories on health care-associated infection and/or patient participation in hand hygiene, please provide us with the link by sending an email to savelives@who.int.

You may remember that Hand Hygiene Australia had kindly agreed to make their online web-based application for hand hygiene compliance monitoring (HHCApp) freely available for use by other national campaigns or health-care facilities. This is part of an International Data Collection Project, supported by WHO, launched in February 2013. We are pleased to let you know that many facilities from 16 different countries have already joined this project so far.

Heading to 5 May, use or reuse the WHO Hand Hygiene Self-Assessment Framework (HHSAF) to get a situation analysis and track progress at your facility! After completing the HHSAF, use and adapt the WHO Template Action Plans to implement your plans for local improvement! Select one action to target for 5 May 2013!

### The WHO call to action this year:

- New registrations from at least 5 new countries (having no registrations), and increased registrations in countries with low numbers (at least up to 5 per country)
- Continue to focus on hand hygiene monitoring and feedback!
- Action on patient participation in hand hygiene promotion - "Patients have a voice too! "

### INVITATION TO SUBMIT MANUSCRIPTS

We invite you to submit your manuscripts to be considered for publication in the International Journal of Infection Control (IJIC). The aim of the journal is to provide a forum for infection control (IC) professionals to disseminate research and practice information and encourage IC initiatives on an international level.

The journal is fully electronic and can be accessed at http://www.ijic.info. The submission is performed online and you can keep track of the whole process in the authors' section of the IJIC website. Submissions can be:

Review articles: 5000 words maximum; comprehensive references; 5-10 key words; unstructured abstract up to 250 words.

Original articles: 5000 words maximum; comprehensive references; 5-10 key words; unstructured abstract up to 250 words.

Short reports: Case reports can be submitted if they illustrate some exceptional point in the field of infection prevention and control. 1000 words maximum; up to 10 references.

Practice Forum: Submissions of a more descriptive account of how IC practitioners or teams tackled a specific challenge or brought about improvement in the prevention or control of healthcare-associated infections in their institution or country. 2000 words maximum; unstructured format.

Letters to the editor: Correspondence to the Editor may refer to material published recently in IJIC or alternatively describe brief accounts of new observations or on other matters of interest. 500 words maximum; unstructured format.


