WHO–5 May 2014–Global Surveys

WHO has now launched the global surveys that are part of the 5 May 2014 call to action:

- The WHO Global Laboratory-based Survey on MULTIDRUG-RESISTANT ORGANISMS (MDROs) in Health Care focused on the burden of five selected key MDROs isolated from blood and urine (MSU & CSU) culture specimens routinely submitted to participating laboratories for in-patients.
- The WHO Global Prevalence Survey on use of SURGICAL ANTIBIOTIC PROPHYLAXIS aimed at obtaining a snapshot of
 antibiotic prophylaxis used, from patient records in surgical wards in a wide range of acute health-care facilities, which can
 participate with an option of choosing any number of general surgery, and/or orthopaedic, and/or gynaecology and obstetrics and/or urology wards.

WHO is also now launching its first new promotional poster that we hope will be used all around the world to promote the role of hand hygiene in preventing the spread of AMR organisms - you will find this here <u>http://www.who.int/gpsc/5may/</u> EN PSP GPSC1 5May 2014/en/.

The aim of the journal is to provide a forum for infection control (IC) professionals to disseminate research and practice information and encourage IC initiatives on an international level.

The journal is fully electronic and can be accessed at <u>http://www.ijic.info.</u> The submission is performed online and you can keep track of the whole process in the authors' section of the IJIC website. Submissions can be:

Review articles: 5000 words maximum; comprehensive references; 5-10 key words; unstructured abstract up to 250 words.

Original articles: 5000 words maximum; comprehensive references; 5-10 key words; unstructured abstract up to 250 words.

Short reports: Case reports can be submitted if they illustrate some exceptional point in the field of infection prevention and control. 1000 words maximum; up to 10 references.

Practice Forum: Submissions of a more descriptive account of how IC practitioners or teams tackled a specific challenge or brought about improvement in the prevention or control of healthcare-associated infections in their institution or country. 2000 words maximum; unstructured format.

Letters to the editor: Correspondence to the Editor may refer to material published recently in IJIC or alternatively describe brief accounts of new observations or on other matters of interest. 500 words maximum; unstructured format.



Quality Improvement and Safety and its "Adiós Bacteriemias" ("Goodbye Bacteremia) Initiative Task Force

This initiative joins together organizations; hospitals, scientific societies and experts to demonstrate that it is possible to prevent central line-associated blood stream infections (CLABSI) by implementing evidence-based interventions, and standardizing a strategy of multi-country collaborative work.

The first phase of this campaign, launched in September 2012, aimed to reduce the incidence of CLABSI in Latin American Intensive Care Units by 50%.

The Task Force provided 18 virtual learning sessions about the implementation of every component of the bundle, baseline and process measures, and data management. 40 ICUs participated in this first phase, of which 31 reported data on a monthly basis. The results show an overall reduction of 56% in the rate on CLABSI. This reduction represents an estimated impact of 336 CLABSI episodes prevented, a reduction of a total of 2352 hospital inpatient days, 3.4 million dollars saved and 84 lives saved¹.

Based on these results and with the aim of scaling up the intervention to other Latin American ICUs, the CLICSS will be launching the second phase of the initiative 'Goodbye Bacteremias: Increasing the Impact' on April 22th, 2014 at 10.30Hs Mexico-Colombia, 11.00Hs Caracas, 11.30Hs Boston, 13.30Hs Buenos Aires via Webex.

We are pleased to invite you to join the initiative as our strategic partner. We would like to have your support during the second phase of the initiative to reach more institutions and build local capacity within your networks and your country.

We envision your role in this strategic alliance as one of endorsement and support. The support could consist of outreach and dissemination on the initiative through webpages and social media, participation in learning sessions, harvesting 'stories from the field' (from participating institutions), providing access to your platforms and networks to enhance reach and visibility, and offering technical expertise.

The Task Force would disseminate your work through the <u>CLICSS</u> webpage and social media, and would recognize your support in the learning sessions.

We deeply appreciate the opportunity to continue to explore avenues of collaboration as the effort unfolds. Please do not hesitate to contact us should you require any further information.

Call for expressions of interest to collaborate with IFIC in the scientific organisation of its International Conference in 2016

IFIC invites expressions of interest from European Member Societies, who are interested in having the 16th international IFIC conference, scheduled for 2016, held within their country and to collaborate with IFIC in its organisation.

IFIC European conferences are normally held between February and April of every year. Nevertheless, exceptions and compromises may be possible, especially related to weather and clashes with other major conferences in the region/globally.

IFIC will:

- * Organise the conference in collaboration with the chosen Member Society.
- * Own the full rights of the event.
- * Entrust its Congress Organiser to act as the core conference organizing agency and to undertake all organisation issues relevant to the running of this event. These include all aspects related to:
 - ◊ registration of delegates
 - ◊ venue arrangements (including catering, etc.) except where explicitly agreed beforehand
 - ♦ hotel coordination
 - sponsor contracting and invoicing, allocation of booth locations and all other logistic issues related to the exhibition
 - preparatory and administrative activities normally related to the organisation and running of an international conference
- * Extensively disseminate information about the conference among all our members and use IFIC's channels to attract international attendees.
- * Advertise and pay for a number of scholarships to the conference. These will be open to all IFIC member societies and adjudicated by the IFIC scholarships committee.
- * Be ultimately responsible for the collation of the academic programme, allocation of scholarships and choice of posters and delegate free papers.

The collaborating Member Society will:

- * Suggest to the IFIC Congress Organiser potential venues where the conference could be held and be consulted in the process of deciding on the final choice.
- * Participate actively in preparations for the Scientific Programme of the Conference. To this end, it will nominate a member/s to the Academic Committee as well as reviewers for scholarship and free paper abstract submissions.
- * Promote the meeting amongst the local members and within the region through regular announcements by mail and/or e-mail dissemination.
- * Send out the conference sponsorship manual to its own company mailing list and use its personal contacts to invite exhibitors to the congress.
- * Undertake translation of the conference web page and the website registration pages into the local language, if it deems this to be necessary

Benefits for the collaborating member society:

Society members have the option of benefiting from a reduced preferential registration fee. This reduced fee should be given only to the paid up members of the Society and, if taken up, will be collected directly by the Society and then transferred to the Organiser.

The Society may organise a pre- Conference one day course or meeting for its members. IFIC will cover costs related to venue and audio visual equipment but all other costs for this pre-event including those related to its organisation, speaker expenses, catering, etc., must be borne by the Society, which will take full responsibility for the local logistics related to the running of this event.

The Society may appoint a local organizer to organise this pre-conference event. In all cases, full communication and agreement with the IFIC Conference Organiser must be undertaken in all preparations for this event. Furthermore, in order to ensure a smooth running and to avoid confusion at the Congress site, the Conference Organiser shall be informed of all plans, numbers, catering needs, speakers and audio visual needs at least 2 weeks prior to the event.

The Society will receive 100% of net revenues generated from companies exhibiting only for the pre-Congress course day.

Expressions of Interest continued

The Society is also free to source additional sponsorship revenues from local or international companies. In such cases, profit sharing arrangements will take into account expenses incurred by both parties, and will be agreed beforehand.

Expressions of interest should contain:

- * Suggestions about the city/cities where the conference could be held as well as possible conference venues and dates (preferably March).
- Information about recent infection prevention and control conferences held by the Member Society; including: when were they held? How many attendees were present? Were these only doctors or was the audience multidisciplinary? What was the registration fee?
- * An estimate of the number of delegates from the region, including neighbouring countries that can be confidently expected to participate in the IFIC2016 conference.
- * Information about visa requirements for delegates, especially for those outside Europe.

Expressions of interest should be sent to <u>conferences@theific.org</u> by **no later than 30 June 2014.**

The Conferences Committee will make a recommendation to the Executive, and the Board, based on the expressions of interest received, and an assessment of the adequacy of suggested facilities, etc. The final decision will be communicated by the IFIC Board by end November 2014 and will be final.

A Memorandum of Understanding will be signed by IFIC and the Member Society, formalising and clarifying their respective tasks in the organization of the congress, and the benefits each party will be entitled to, based on this planned collaboration.
