The Membership base, both in terms of Societies working in the field of Infection prevention and control, and in its associate membership category, continues to expand.

Our new system of geographical representation on the Board of Trustees will hopefully help us to ensure that all areas of the globe are represented on an equitable basis, thus supporting our aim to be the leaders in global infection prevention & control networking. The importance and relevance of the Federation not only to those working in countries with limited resources but also to those in higher resource settings was evidence this year, when over 10 nominations were received for 5 vacancies.

Some of these vacancies were carried over from the previous year, others have occurred due to the retirement of three long standing colleagues, all of whom had worked unstintingly on behalf of IFIC. Our best wishes and a very fond farewell to Gayle Gilmore, who served as Chair of the Education

# Eleventh Congress of the International Federation of Infection Control

(SIMPIOS) held its 11th International Conference in Venice. The Congress ran from 12



The opening ceremony lecture was presented by Giuseppe Cornaglia on Infection Control in the Middle Ages: a Venetian story of quarantine and lazarettos. Keynote lectures were presented by William Rutala, Silvio Brusaferro, and Gary French.

Symposia sponsored by various professional organizations were provided on MRSA, device-associated infection prevention bundles, structures of hospital hygiene and infection control in Europe, achieving the critical balance in infection prevention, carbapenemase resistant Enterobacteriacae, infection prevention in a high resource country, WHO Clean Care is Safer Care, and the UK experience to reduce infections. There were also debates on mandatory reporting and hand hygiene compliance.

Hands-on experience was offered during workshops and in viewing exhibits. There were also meet the expert sessions with William Rutala, Smilja Kalenic, Elizabeth Scicluna, Claire Kilpatrick.

The IFIC chair, Judith Richards, ended the conference by reviewing the year in infection control.

The Board has continued its work in revising and expanding its aims and objectives, and this has led to an extensive review of the Memorandum and Articles of Association. We hope the key changes, presented at this year's AGM, will meet with the support and approval of all our Members, thus enabling IFIC to move forward with its strategic plans.

IFIC is greatly indebted to all those who contributed to this new edition, either as authors or as reviewers. Our greatest thanks go to the Editors Candy Friedman and Bill Newsom, without whom this fantastic achievement would not have been possible!

We would like to take this opportunity to express our warmest thanks to our Strategic Partners for their continuing support. In this instance, it is a great pleasure to single out not only those who supported our projects and meetings, but also to BD, whose generous contribution helped to print the book, and is now ensuring we meet our target of translating it into Spanish and Portuguese (Brazilian) to ensure even wider distribution and readership.

The annual conference continues to be one of the key eagerly anticipated events of the year, and this year's partnership with SIMPIOS resulted in an outstanding Conference in a beautiful venue. Over 600 delegates met just outside Venice, and participated in fruitful exchanges over 3 days of lively and stimulating scientific sessions. Many thanks go to Michael Borg (conference coordinator) and SIMPIOS for a challenging and well organised conference!!

## Making Safe Injection and Disposal a Reality

## Special Interest Group - Safe Injection Practices

In many parts of the world safe injection practices, as well as proper disposal of sharps remain a challenge. Infection prevention is integral to solving many of these problems. A number of initiatives have been put forth to address these issues; however, the success of these interventions is not well documented and in some locations problems still persist. In order to address this gap, IFIC is launching a Grant Proposal Competition aimed at infection prevention in low-resource settings. This initiative is made possible through the generous support of several companies: Stericycle, AP Medical, Smiths Medical, and WNWN International.

This call for applications is being coordinated by the IFIC Safe Injection and Disposal Special Interest Group, which seeks proposals for projects to assess current injection practices and/ or disposal methods in any health care setting and methods that can or have been implemented to improve them. The grant will be awarded so that the investigators can implement their proposal and measure results.

This project must result in an English language manuscript for publication or a presentable abstract. **Two (2) Grant requests will be awarded, limited to US \$3500 each.** This request for proposals is for a one-time, one-year project.

The deadline for applications is November 15, 2011.

## **World Health Organization**

WHO SAVE LIVES: Clean Your Hands is now aiming to galvanise action for 5 May 2012; the 4<sup>th</sup> year for this global campaign in celebrating the move towards clean hands in health care, every day; everywhere.

The call to action for 5 May 2011 was to track your progress with hand hygiene improvement. As part of this, health-care facilities were asked to use the WHO Hand Hygiene Self Assessment Framework. This tool has been downloaded almost 55,000 times and many are using it to demonstrate their status; trying to ensure good hand hygiene practices are sustained in their settings. It is clear that health-care facilities in many countries understand that results from this tool can help them present the case for support/ resources to improve hand hygiene. Some settings have been surprised at their scores and how much still needs to improve. At this year's IFIC Congress, a poster submission from the Netherlands on use of the WHO Hand Hygiene Self Assessment Framework won the 2nd place award in recognition of poster quality and educational merit.

As part of supporting hand hygiene improvement progress, in 2012 WHO will present data on completed Frameworks, based on a global survey which is under way until December 2011. ## 8th International Healthcare Infection Society (HIS) Conference and Federation of Infection Societies (FIS) annual conference

The FIS/HIS Conference is a unique collaboration between all organisations who have an interest in infection in its broadest sense in the UK (FIS), combined with the biannual HIS International Conference. HIS is returning to Liverpool, one of Britain's most vibrant and cosmopolitan cities, after the very successful



2010 HIS International Conference. The 2012 event will again be located in the BT Convention Centre, a purpose built, state of the art facility situated in the heart of Liverpool along the historic, world heritage waterfront.

The HIS conference takes place every two years and is the major international conference focusing on infection control attracting leading world experts in healthcare associated infections as speakers and delegates. As well as attracting accreditation from both the ACCME and the Royal College of Pathologists, it will provide a unique opportunity for everyone involved to learn the latest developments in this rapidly expanding and changing field.

The meeting is driven by an excellent scientific programme covering topics such as infection prevention and control, epidemiology and surveillance, decontamination, new technologies, infectious diseases, laboratory microbiology and antimicrobial agents to name a few. There will also be an opportunity for delegates to exchange views and ideas about the latest developments in nosocomial and hospital acquired / healthcare associated infections - always such an important part of this meeting for all parties.

## Inaugural meeting of an IFIC Special Interest Group on "Infection Control in home and everyday life settings"

The inaugural meeting of this new Special Interest Group took place at the IFIC conference in Venice on Friday 14 October 2011. The need for a special interest group on this issue stems from the increasing amount of health care and care of other vulnerable groups (e.g., the elderly as well as the very young) taking place in the home. Healthcare workers are also now recognising that reducing healthcare-associated infections in hospitals cannot be achieved without also reducing circulation of pathogens in the community. These factors are prompting increased demand for support materials on hygiene in the community from healthcare workers.

The mission of the group, as agreed at the inaugural meeting, is to establish a partnership between IFIC and the International Scientific Forum on Home Hygiene (IFH, <a href="www.ifh-homehygiene.org">www.ifh-homehygiene.org</a>) in order to provide IFIC members with a resource through which they can obtain information, identify support needs, and exchange practical knowledge and views on infection prevention and control in home and everyday life setting. The main goals of the group are:

- To raise awareness of the importance of infection in home and everyday life settings
- To support the development and promotion of infection prevention in home and everyday life, both in developed and developing countries
- To ensure that infection control practices carried out in these settings are based on sound scientific evidence

Our immediate planned actions are:

- To assemble a database of IFIC members with special interest in infection prevention in home and everyday life settings and gaining an understanding of their needs
- To establish a webpage on the IFIC website, and developing it to give IFIC members access to currently available materials (guidelines, training resources, public advice sheets, etc.) on infection prevention in home and everyday life settings.
